### **Florida Department of Transportation**

On October 12, 2008, Officer Michael Howell, conducted a traffic stop of a commercial vehicle, on Interstate 10, in Walton County, Florida.

Officer Howell on conducting a commercial vehicle inspection found several indicators of ongoing criminal activity. Officer Howell deployed K-9 Max to conduct an exterior sniff of the commercial vehicle.

K-9 Max responded with positive alerts, to a narcotic odor emitting from within the commercial vehicle.

A subsequent search resulted in the discovery of 150 kilo packages of cocaine, weighing 350 lbs, along with \$3000 dollars in US currency. The packaged cocaine was hidden between pallets a Coke-a-Cola.
