## CRIMINALISTICS TOP CASE OF THE YEAR 2010 - Sponsored by Criminalistics

### “MONZA” AWARD - Sponsored by American Aluminum

#### Corporal Mark Picard and K-9 Schultz - Gloucester Twp. NJ PD



On November 30, 2010, at approximately 1909 hours, officers responded to the Lucky Dragon Chinese Restaurant at 408 East Church Street for report of a robbery (10-46044). It was reported that two males had entered the restaurant, where they physically assaulted the employees, demanded money from the cash register, and left with the proceeds through the rear of business. Numerous patrol units responded to the scene, including Cpl. Mark Pickard #120 and K-9 Schultz. Cpl. Pickard and K-9 Schultz successfully located and conducted a track of the suspect through the nearby residential area for approximately one-and-a-half miles. Cpl. Pickard and K-9 Schultz then located the suspects, who attempted to flee when K-9 Schultz was deployed and made an apprehension on a suspect. The suspect was able to pull Schultz over a distance while continuing to resist and elude capture. The suspect then motioned K-9 Schultz, who was still engaged in the apprehension into oncoming traffic on Route 42. K-9 Schultz was struck by a passing vehicle, which caused him to release his hold. The suspect was then able to flee the scene as officers began to search for K-9 Schultz. K-9 Schultz was located by officers lying in the median of Route 42, where he had succumbed to his injuries.

A command post was immediately established in the parking lot at Highland High School, where police resources were coordinated, and the containment with intensive search of the area was conducted. Police officers, both on and off duty, from numerous Camden and Gloucester County agencies assisted, as well as the New Jersey State Police and Philadelphia Police Aviation Unit. Numerous other K-9 teams from surrounding areas, who responded while off duty, also assisted. Additionally, various Gloucester Township fire department and EMS personnel provided their services and assisted in maintaining numerous scenes.

One suspect, Skyler Robinson, who was initially involved in the apprehension and subsequently caused the death of K-9 Schultz was eventually captured in the Knoll Run development. The command post was terminated shortly thereafter after a thorough and exhaustive search of the area for the second suspect. Further investigation successfully led to the identification of the second suspect, Evan Scotese, who was later apprehended early in the morning on December 1, 2010, at his home in Washington Township. Skyler Robinson was charged with robbery, conspiracy to commit robbery, inflicting harm on a law enforcement animal, resisting arrest by flight and cruelty to animals. Evan Scotese was charged with robbery, conspiracy to commit robbery and resisting arrest by flight. Both accused were eventually remanded to the Camden County jail in default of \$150,000 full cash bail.

The Case of the Year Award is given for an act of intelligent and valuable police service, demonstrating special faithfulness or perseverance, including an important arrest that is accomplished through highly intelligent police performance. Schultz, successfully led to them quickly tracking the suspect approximately one-and-a-half-miles from the scene of the crime. This led to them locating the suspect, who attempted to elude police. Their successful track was a critical turning point in the chain of events

that led to the capture of one of the violent robbery suspects, who would have undoubtedly have escaped and been a further danger to society.

Because of his faithfulness, courage and training, K-9 Schultz fearlessly and relentlessly battled with a dangerous criminal and attempted to stop this violent suspect, which, unfortunately, ended with Schultz's death.

### **MONZA AWARD - Sponsored by American Aluminum**



#### **Deputy Jared Zeller and K-9 Viper, Brunswick County NC**

On July 17, 2011, the Drug Enforcement Unit requested the assistance of Deputy Jared Zeller and his K-9 partner, Viper. DEU agents arranged to make a controlled purchase of one kilo of cocaine from suspects Jamie Gonzalez and Barulio Marin. Agents, along with Deputy Zeller and Viper, followed the suspect vehicle to a corn field in the Ash area of Brunswick County. Deputy Zeller was tasked with conducting an article search of the corn field utilizing his partner, K-9 Viper. While conducting the article search, K-9 Viper found and recovered approximately 1.1kg of cocaine. The cocaine was wrapped in what appeared to be cellophane plastic and black electrical tape. During the retrieval, K-9 Viper punctured the electrical tape and cellophane wrapping. K-9 Viper ingested an unknown quantity of cocaine. Upon discovering that K-9 Viper had ingested the cocaine Deputy Zeller took immediate and appropriate actions to care for his dog. Deputy Zeller transported K-9 Viper to a veterinary hospital to be treated. Unfortunately, K-9 Viper succumbed to his injuries sustained during the article search. Deputy Zeller and K-9 Viper's work led to the arrest of two Mexican nationals and the seizure of 1.1kg cocaine, 1,092 dollars in US currency, and a 2005 Ford Explorer.

#### **Officer Joe Fuller & K-9 Shadow**

#### **Minneapolis, MN Police Department**



On 03/30/2010, officers from Minneapolis' 4th Pct. stopped a motorist for alcohol related infractions. Officers made contact with the driver and passenger. Unknown to the officers making the stop, the driver had been convicted of manslaughter and other aggravated assaults. He was also armed with a handgun and knife during the stop. The driver then sped off, leading officers on a pursuit out of the city and into neighboring suburbs. K-9 Officer Joe Fuller and his K-9 Shadow joined the pursuit to assist in the event that the suspects ran from the vehicle. Stop sticks were deployed and slowed the suspect's vehicle enough so that a State Patrol

squad could move into position to PIT the suspect. This maneuver was successful, and the suspect's vehicle crashed into a ditch.

The driver and passenger both ran from the vehicle into a wooded area. K-9 Shadow was deployed to apprehend the suspects. Twenty yards into the woods, K-9 Shadow apprehended the passenger in the upper back area and the suspect was taken into custody by assisting squads. K-9 Shadow was then re-directed into the woods to find the driver. As K-9 Shadow searched in the woods, there were still numerous sirens and other noises blaring making it difficult for Officer Fuller to keep contact with Shadow. Once the sirens were shut off, Officer Fuller called for Shadow, and the dog emerged from the woods with serious injuries. K-9 Shadow had been stabbed while he apprehended the driver. There was a 4-inch deep plunging stab wound between his shoulder blades and two 12-to-14 inch long slashes on his left front leg. K-9 Shadow was bleeding profusely and needed immediate medical attention.

Officer Keith Demarest of the Mounds View Police Dept. was providing cover for Officer Fuller during the search. When Officer Demarest saw Shadow's wounds, he tore off his t-shirt and provided a tourniquet and provided direct pressure to Shadow's wounds. He also jumped into the back seat kennel with Shadow as Officer Fuller drove to a nearby 24-hour emergency veterinary hospital. The regular vet would have been too far away for Shadow to survive. Blaine Police Officers directed the way to this hospital and provided an emergency escort.

Once at the hospital, Doctor Dawn Todd performed emergency surgery on Shadow and was able to close his wounds. Doctor Todd's diagnosis was that K-9 Shadow would have died from his attack if not for the tourniquet, direct pressure and close proximity of the hospital.

This case is being submitted for Case of the Quarter for K-9 Shadow's relentless pursuit of a felon and his ability to survive a deadly attack. It also points out the need to be prepared for emergency situations, if and when a K-9 needs it.

### **Officer John Jorgenson & K-9 Major**

#### **Roseville, MN Police Department**



The following incident occurred on 07-11-10 at approximately 0150 hours.

At approximately 0150 hrs Officer John Jorgenson monitored Officer Adams, who was in a vehicle pursuit. Officer Jorgenson began responding to the area to assist. He paralleled the pursuit on Hwy 36 as it was heading EB on Co Rd B. Officers were updated that the vehicle was coming back stolen. Officer Jennings updated units that the pursuit ended on Edgerton St, south of Co Rd B. Officer Jennings provided a clothing description and stated that the adult male driver fled eastbound. Jorgenson responded to the scene and removed his USPCA certified K-9 Major from the squad to attempt a track of the driver. He made a K-9 warning and began a track from

the last known location the driver was seen. Maplewood Officer Marino provided cover. The track began to the east around the north side of 2086 Edgerton. K-9 Major was tracking hard with his nose on the

ground. It was raining hard. The team tracked approximately 150 yards to the east, where they came to some heavy brush that was surrounding Oehrline Lake. K-9 Major entered the water and began air scenting.

Officer Jorgenson gave another K-9 warning and did not receive a response. He removed K-9 Major's lead and allowed him full access to the lake and shoreline. He made the decision to allow K-9 Major the chance to apprehend the suspect after weighing the following factors:

\*\*\*The suspect was wanted for felony level offenses (flee police and auto theft).

\*\*\*The suspect fled into a densely populated residential area, and it was unknown if he was armed.

\*\*\*The suspect was actively fleeing to avoid capture.

\*\*\*The suspect was given several K-9 warnings to surrender with negative results.

\*\*\*Jorgenson was fearful that the suspect may try to ambush officers from a concealed position.

K-9 Major swam to the northwest along a peninsula that stretched into Oehrline Lake. Major then exited the water and began running along the shoreline trying to locate the suspect. Jorgenson gave another K-9 warning and did not receive a response. K-9 Major re-entered the water and began swimming to the north along the shoreline. He was out of view, when Jorgenson heard him apparently struggling with the suspect. The officer moved toward the shoreline and saw Major had apprehended the suspect by his right arm. The suspect purposely moved out into deeper water and ignored commands to come to shore. The suspect was approximately 25 feet from shore in water up to his neck.

Jorgenson saw that the male Major was apprehending matched the description of the driver that fled from the stolen car. The suspect then took hold of K-9 Major's collar and pulled his head and body under the water in an obvious attempt to drown him. Both the suspect and K-9 Major went under water for over five seconds. Jorgenson entered the water and pointed his duty weapon at the suspect. He ordered the suspect to stop fighting with the dog. The suspect again pulled Major under the water. The suspect was swearing at the K-9 and officers.

Jorgenson was fearful that the suspect was going to kill his K-9 partner. He waded further into the water as the male attempted to swim away from K-9 Major and himself. K-9 Major briefly bit the suspect on the head but released the suspect when they resurfaced. The suspect continued to take hold of Major as the dog pursued him and pulled Major under the water several more times. Jorgenson was in the water up to his chest as he closed in on the suspect. He was holding K-9 Major under the water trying to kill him. Jorgenson delivered a right forearm strike to the side of the suspect's head in order to save his partner. It should be noted that this was the only area of the suspect that was above water. The suspect temporarily released K-9 Major but continued to try and flee from officers and the dog.

As the suspect moved toward the shore, K-9 Major bit him on his lower back but was unable to hold the suspect. The suspect was in thigh-high water and turned and grabbed K-9 Major's collar again. He threw himself on top of Major causing Major to go under water for several seconds. The male then attempted to flee onto the shoreline. Jorgenson tried to push the suspect down as K-9 Major took hold of his leg. The suspect continued to actively fight with officers and ignored commands to lay on his stomach. Jorgenson delivered several more elbow strikes to shoulder and midsection of the suspect in an attempt to knock him down. K-9 Major continued to apprehend the suspect by the lower legs as he kicked and refused to be handcuffed.

At that point, Jorgenson attempted a "drive stun" with his Taser to the suspect's lower back but didn't know if the Taser worked, because it had been submerged. The suspect did not appear to be affected by the attempted Taser stun. Officer Marino was eventually able to handcuff the suspect on the shoreline.

Jorgenson updated dispatch that the suspect was in custody and had officers order medics to the scene. Maplewood officers escorted the suspect to Edgerton, where the pursuit ended. Police Paramedic P. Bartz evaluated the suspect at the scene and said he was stable enough to take to the hospital. Jorgenson advised Sgt. Wahtera that he had pain in his right forearm from delivering several forearm strikes to the suspect. Jorgenson had some "tingling" sensation in his right hand and finger tips. Sgt. Wahtera advised him to get it checked at Regions hospital. Jorgenson went to Regions hospital and was treated in the ER for a contusion and swelling. Officer Jennings took photos of the suspect's injuries. (See her report.) Jorgenson completed a departmental IOD form. When he downloaded his Taser info at RPD, it did not show a Taser deployment around the time of apprehension (approximately 0205.)

On October 26<sup>th</sup>, 2010, Officer Sanow was dispatched to a residence for a residential fire. Upon his arrival, he discovered the house engulfed in flames. He exited his squad and began to run to the residence to check for any victims. Seconds later, he was ambushed and fired upon by the resident and received a 12-gauge slug to the chest. He was saved by the vest he was wearing that night. Due to his training and bullet proof mind, he was able to get to safety and alert others in the area about the shooting .He also coordinated others responding to the scene. It was later discovered the suspect died of a self-inflicted gun shot. Chad since then has been awarded several commendations for his bravery and heroics.
